CAMP/SCHOOL/INSTRUCTOR: Ski and wake camps, schools, instructors and coaches.

**ASSOCIATION:** Groups, communities, foundations, non-profits and other organizations involved in water sports.

**FRIEND OF THE INDUSTRY:** Other promoters, supporters and fans of water sports.
